CLS has three openings for two-year, grant-funded staff attorney positions in the CLS Housing Unit, under the UniteCT program and the Right to Counsel program. The attorneys will be assigned to CLS office locations and handle cases in their office's geographic coverage area. Coverage might extend to other areas at least while proceedings remain remote.

Responsibilities shall include, among other things, Legal representation and advice to individuals and families who are at risk of homelessness and are being evicted and may be eligible for emergency rental and/or utility assistance through UniteCT.

The attorneys will receive extensive training in the UniteCT program and other areas of housing law and will be expected to:

- maintain an active caseload of representation and advice cases which will require regular remote court appearances (and in person court appearances as the courts reopen), and administrative hearings, as appropriate;
- conduct community outreach and coordinate with other social service agencies working with our clients; and
- help identify larger trends and issues for our clients, and work to develop strategies to respond to those trends and issues.

PREFERRED QUALIFICATIONS:

- Deep and demonstrated commitment to advocacy on behalf of low-income, vulnerable, and marginalized communities, and to CLS' mission, vision, goals, and values;
- Spanish language fluency;
- Excellent interpersonal and communication skills, including the ability to write persuasively and clearly and the ability to communicate effectively with diverse populations;
- Demonstrated ability both to collaborate closely with colleagues and also to work independently when necessary;
- Creativity and flexibility in solving problems and meeting challenges;
- Connecticut bar admission or passed the Connecticut bar exam and willing to be sworn in;
- Knowledge and experience in Connecticut court practice.
