Connecticut Legal Services, Inc. (CLS) seeks committed attorneys to fill temporary fellowship positions in our transformative work under Connecticut's new Right to Counsel (RTC) program. RTC focuses on eviction defense and other housing matters. These temporary positions in the housing unit are available in Bridgeport, Waterbury, New Britain, and New London and will run through December 2024. There is a possibility that the positions will be extended, dependent on funding. Attorneys will handle cases in their office's geographic coverage area, as determined by the priorities of the RTC program. Attorneys will receive extensive training in the RTC program and other areas of housing law.

Attorneys are expected to:

- maintain an active caseload of representation and advice cases, including regular remote or in-person court appearances and administrative hearings appearances
- conduct community outreach remotely and in-person, and coordinate with other social service agencies working with our clients
- help identify larger trends and issues for our clients, while working with the CLS Housing Unit to develop strategies to respond to those trends and issues

QUALIFICATIONS

- Deep and demonstrated commitment to advocacy on behalf of low-income, vulnerable, and marginalized communities, and to CLS' mission, vision, goals, and values
- Connecticut Bar admission no later than November 2022
- Spanish language fluency (preferred)
- Excellent interpersonal and communication skills, including the ability to write persuasively and clearly, and the ability to communicate effectively with diverse populations
- Demonstrated ability both to collaborate closely with colleagues and also to work independently when necessary
- Creativity and flexibility in solving problems and meeting challenges
